

The President's Report

We continue to feel the current downturn in the oil and gas industry and how it affects our personal lives as well as the Canadian Well Logging Society (CWLS). We knew coming into last year that it would be a year in which we would have to make choices and take decisions keeping in mind the financial stability of the society and the value it brings to our members. With that in mind, the CWLS Executive has taken some strategic initiatives this past year that will not only position the society in a better financial position for the coming years, but equally important enhance the technical value we provide to our members.

I am extremely proud of the time and effort our 2016-2017 CWLS Executive team dedicated to the society, the results we achieved, and having the opportunity of working alongside with the support of our honorary and key senior members. Some of the major decisions, such as the motion to become a local SPWLA Chapter were taken with consultation from our general membership with an online survey. I personally want to thank all the members who participated in the survey and gave us feedback, and the ones who ultimately participated by voting for the SPWLA chapter motion online. I am confident that we will see the results of our efforts in the coming years, I invite you to take the time to read about all the hard work the CWLS Executive dedicated to the Canadian Well Logging Society in 2016.

Finances

The treasurer's report will go in more detail analyzing our profit and loss statement for last year, however I want to give an overview of the CWLS finances for 2016 and explain some of the decisions taken that we feel will position the society in better shape for the upcoming years.

Historically the main source of revenue for the society has been through the GeoConvention Partnership (GeoConvention), and we receive our percentage of the total revenue generated based on the joint partnership agreement we have in place with the Canadian Society of Exploration Geophysicists (CSEG) and the Canadian Society of Petroleum Geologists (CSPG). After the GeoConvention board had wrapped up the conference and completed their financial examination, they concluded that despite the overall success of the conference, it had run at a small deficit and therefore the CWLS would not receive any revenue for 2016. This is unprecedented for recent times and it goes to show the impact the downturn has had here in Calgary.

When I took on the role as President of the CWLS; one of the areas I wanted to lead some initiatives was in reducing the societies cost since we knew that 2016 would be a difficult year, some of those initiatives were accelerated when we received the news that the society would not generate revenue from GeoConvention. Without going into much detail in the profit and loss statement, in 2016 we had a significant reduction in our

overall revenue, but thanks to the initiatives to reduce costs, we also managed to cut our expenses for the year.

CWLS Office Change

In 2016 the CWLS physically moved to a new office as a result of switching from APEGA to Associations Plus for our administrative support. The CWLS will always appreciate the great support that we have received from APEGA for many years, and after a successful transition to Associations Plus we look forward to working with them. Based on the experience so far, the CWLS Executive is confident that by switching to Associations Plus, not only allow will improve the efficiency of the societies day to day operations but also reduce our administrative cost.

SPWLA Chapter Motion

As most of the CWLS members are aware the CWLS is the oldest organization devoted to log analysis worldwide, incorporated in Calgary, Canada in 1957. The society has a rich and successful history of bringing together our technical petrophysical community by hosting monthly technical luncheons, as well as supporting our members with initiatives such as the Catalog of Water Resistivities in sedimentary formations in western Canada.

During the last couple of years, the industry downturn has had a significant impact on our society, it is no secret that our general membership has dropped from 600 members to around 250 active members. We have also seen a drop in our corporate sponsors and our main source of revenue, GeoConvention, has also been affected as mentioned above.

The initiative to conduct a survey and eventually a vote to allow the CWLS Executive to start negotiations with the Society of Petrophysicists and Well Log Analysts (SPWLA) to become a local chapter, is not only being considered due to our current financial situation, but also in part because we have experienced lower involvement of our local petrophysicist members. I believe that by being part of a larger worldwide technical community such as the SPWLA, our members will have added benefits, which I believe ultimately enhances the value of becoming a member.

The survey conducted online had a positive participation and we gathered all the feedback our members gave us. Over 85% of the members who participated in the survey expressed their approval to become a local SPWLA chapter. We also received some valid concerns from a small portion of our membership, and those were addressed at two technical luncheons and in the form of supporting documents posted on our website. The decision to conduct both the survey and the vote online, was taken in order to maximize the participation from our general membership.

The voting for this motion will close 2 days prior to the AGM, to give the CWLS Executive time to gather the results and present them at the AGM. I want to thank everyone who participated in the survey and in the final vote.

The Winston Karel Student Scholarship

As some of you may remember, last year the CWLS re-named the student scholarship to honor Winston Karel, a long standing member and contributor to our society. The CWLS is honored to receive a donation from Lois Decker through Blade Ideas Ltd, to once again sponsor the student scholarship which will continue to carry her husband's name. This year the winners of the scholarship will be announced later in the year during a luncheon event, this decision was made in order to collect the proper amount of student abstract submissions.

Acknowledgements

On behalf of the CWLS, I wish to acknowledge and thank APEGA for their continued support. Anita Denton continued to be a key member of the CWLS team and was invaluable as we transitioned the societies administrative duties to Associations Plus. I also want to thank Erika Holter and Jenny Kerr for their efficient support in taking on the administrative responsibilities of the CWLS.

As mentioned before, the 2016-2017 CWLS Executive had a difficult year, but I am thankful for their dedication and effort put into managing the societies needs.

Closing

It has been both an honour and a privilege to serve as your elected president for 2016-2017. I am extremely grateful to all the volunteers, honorary and senior members that stepped up this year for the CWLS. The executive team was an amazing and diverse group and I would like to reiterate my thanks for all of your hard work, dedication and patience over the last year. I would also encourage all of our members to consider volunteering in one capacity or another; it may not be easy to fit time in with our busy schedules, but the rewards are considerable.

To the incoming 2017-2018 Executive, I offer my congratulations on volunteering to be a part of this unique and vibrant community, and I wish you all continued success for the coming year.



Dear members and executive team at CWLS, thank you for your continued support and patronage over the last year, our 60th consecutive year of operations was challenging for our industry in general, as well as the CWLS and its sister societies, with all associated obstacles we continued our efforts to deliver valuable and high quality monthly technical luncheons.

Unfortunately, even though we received positive feedback on most of our monthly luncheon talk's, attendance had dropped almost by half comparing to previous years, which was a challenge for CWLS to recover costs in most months.

From April 2016 to Feb 2017, total of 9 luncheons where held, 309 tickets were sold, and an average of 34 people attended each lunch.



We aimed to deliver rich content focusing on local Canadian Petrophysics and Log Analysis of conventional and unconventional plays as much as we could, unfortunately finding speakers was another challenge, thanks to all speakers who voluntarily presented at CWLS luncheons last year.

Hopefully, if and once the CWLS become a local chapter of SPWLA, it will be easier to reach out to other worldwide societies to strengthen the synergy among those societies by means of speaker exchanges, increase number of audience at the luncheons and several other activities.

We are very excited about the potential merge with the SPWLA and the fruit that it will bear in terms of technical content.





Treasurer's Report

The accompanying Profit & Loss Statement and Balance Sheet reflect the financial position of the Canadian Well Logging Society (CWLS) for the year ended December 31, 2016. Tiffiny Yaxley (Past-President), Manuel Aboud (President), and Zeyad Ben Ziaied (Vice-President), all members of the CWLS in good standing, in accordance with the CWLS by-laws, have reviewed the financial reports. The CWLS operated at a deficit of \$54,233 for the 2016 year. Total income was \$25,620 and Total Expenses were \$79,854. This year, the executive was able to cut down expenses by 40% from previous years to offset minimal income.

Membership

Total membership income decreased from \$12,715 in 2015 to \$5,522 in 2016. Membership dues were collected at \$40 for practicing members and \$20 for Senior members which offered the lowest dues of any petroleum society in Calgary.

Technical Luncheons

Our luncheons are heavily subsidized by the society to maintain affordability for all members and non-members alike. The cost to CWLS on a per plate basis is approximately \$55. Members pay \$40 and Non-members pay \$45 per luncheon ticket. Corporate tables are purchased for \$400 per table which seats 8 people. The CWLS reserves a table every luncheon for student attendance at no charge to the students.

The total revenue for all 2016 technical luncheons was \$12,148 which is ~40% decline from 2015. The total expenses for running the luncheons was \$19,077 which is ~60% decline from 2015. The executive was able to reduce the luncheon expenses by renegotiating the CWLS catering contract for 2016. 2016 luncheons consistently drew approximately 30-40 people per luncheon.

Annual General Meeting

The AGM is the greatest fixed annual expense for the society. In the past, part of the cost is offset with corporate sponsorship and ticket sales, but this is quite small. Along with low tickets sales and no corporate sponsorship, the CWLS funded the 2016 AGM in its entirety to ensure a minimum attendance. The 2016 Annual General Meeting operated at a cost of \$20,652 which is the same amount spent in 2015.

Publications

The society published the InSite magazine in Spring 2016 online. Free advertising was offered to corporations to provide maximum information to members. However, a deficit of -\$819 was reported for publications as the CWLS was unable to collect 2014 advertising fees from Weatherford and WellSight Systems.

Joint Annual Conference and Short Courses

This was the ninth year that the CWLS has been part of the Joint Annual Conference, GeoConvention, along with the CSPG and CSEG. 2016 was a difficult year for the GeoConvention were they operated at a deficit. Hence, the CWLS did not receive any revenue from the GeoConvention partnership. In efforts to provide the maximum value


to members during the downturn, the CWLS offered one Short course on May 5th, 2016 titled "Exploration Using Integrated Petrophysics" for transition members. The course was a great success and the CWLS charged \$15 per attendee, which made revenue of \$176. This event did not generate any expenses due to the support of Ken Simpson.

Sponsorships and Student Awards

In 2016, the CWLS sponsored the CSEG Foundation and the Earth Science for Society (ESfS) with a total sponsorship amount of \$394. In addition, \$4000 was awarded for the best abstract (\$2000) and best thesis (\$2000) submitted by students.

Summary

Even though, 2016 was a low income year for the CWLS, the society still maintains a very strong financial position. Our Scotiabank chequing/savings account has \$37,908 and our three GIC's are valued at \$96,968 total. Our Scotia McLeod account has \$236,532 earning high interest. By the end of 2016, the member equity for the CWLS is \$363,909.



I have enjoyed serving on the executive and I look forward to serving you again as treasurer again for 2017-2018.
