2014 was a remarkable year for the CWLS despite our industry facing recent economic challenges, falling oil prices, drilling activity reductions and a global industry downturn through the last half of the year. This recent downturn has many people wondering about the future and what it may hold. I am confident that the CWLS will continue to thrive, because we have built a solid foundation through our members and are well positioned for the future and its challenges.

I am very proud that we have seen significant accomplishments this past year - from the new CWLS.org website, increased use of LinkedIn social media as an alternate forum and communication tool, the continued success of GeoConvention and vastly improved student and junior industry professional involvement. I am truly enthusiastic about what we accomplished over the last year, improvements that will continue into 2015 and I remain extremely confident in a very strong future for the CWLS.

#### New Website and Social Media

The transition to a new website provider has been a longer and rockier road than we had initially anticipated. Early in the 2014 term, the Executive became aware of the technical limitations of the old website, so we decided to redesign the website from scratch, building on a platform that would allow future enhancements and functionality and allow the website and society to evolve together. After several months in development, the new-look CWLS.org launched in late 2014. The Executive continues to work closely with the developer to rebuild the new CWLS.org website into a fully functional petrophysics and log analysis resource site. These will include the return of online resources, such as the Rw catalog and core database, as well as improved features - simplified online purchases of Technical Luncheon tickets, Membership renewal and electronic receipt generation.

We are also continuing with our social media offerings. LinkedIn continued to be a valuable tool for the CWLS to broadcast updates and other communications to our members. LinkedIn also continued to evolve as a technical hub of petrophysical activity with regular discussions covering well log analysis. Special thanks to Dustin Menger and William Parrales for continuing to represent the CWLS and the executive on LinkedIn.

#### 2014 GeoConvention

GeoConvention continues to be single-largest annual revenue generator for the CWLS and continues to evolve through our Joint Partnership Agreement with the Canadian Society of Petroleum Geologists (CSPG) and the Canadian Society of Exploration Geophysicists (CSEG). The three societies will continue to split the proceeds 45/45/10 among the CSPG, CSEG and CWLS, respectively. This agreement ensures a solid future for the GeoConvention and continued involvement from the CWLS.

The 2014 GeoConvention again featured amazing representation from the CWLS. In total, we offered 39 technical talks this year, filling the three days with CWLS content

and representing a 39% increase from an already extremely successful event in 2013. In late 2014, Dustin Menger stepped up to help lead GeoConvention as Executive Director and William Parrales has been appointed to the GeoConvention board, ensuring that the CWLS is well represented within GeoConvention for the future.

#### **Students and Sponsorship**

We worked closely in 2014 with various student groups and junior industry associations to increase awareness of the CWLS within the industry's newest members and had particular success with the Young Professionals groups of the SPE, CSPG and CSEG, the U of C's Rundle Group of Geology and PES (Petroleum & Energy Society), the Joli Fou Geological Society at MRU, the P.S. Warren Geological Society at U of A and CSEG's GIFT (Geophysical Industry Field Trip). The CWLS' commitment to sponsorship of these events saw our student participation grow throughout 2014 as a result.

On behalf of the CWLS, I wish to acknowledge and thank APEGA for their continued support. Ashley Pessell and Anita Denton continue to be key members of the CWLS team and were invaluable as we transitioned to our new website this past year.

Manuel Aboud & Doug Kozak 2014-2015 Canadian Well Logging Society Publications Co-Chairs At the conclusion of this past year, our membership included 662 active members (including students), which is an increase of 78 members, and 21 corporate sponsors. While our regular membership has remained consistent over the past few years, there has been a significant downswing in student membership which we worked very hard to change this year by sponsoring student events and offering students spots on courses free of charge if there were extra seats. We continue our affiliation with several student societies, and this coming year have a number of initiatives planned to increase their membership.



Our corporate membership consistent form last year and while industry is slow due to oil pricing, the executive would like to see more corporations pledging their support. Corporate sponsorship plays a big role in enabling the CWLS to carry out its activities. Likewise, developments in the fields of logging, petrophysics and formation evaluation are increasingly important for companies to remain apprised of – especially as our industry looks more and more towards unconventional resource plays. Because our membership has traditionally grown through word of mouth in our technical community, we encourage you to continue to recommend us to your colleagues. Feel free to promote upcoming technical lunches to your peers and, if you are interested in volunteering, there are opportunities to get involved in sub-committees, future GeoConventions, and corporate sponsorship. We are also looking to gain membership from the engineering community thourgh joint talks with the SPE, please look out for these colllabortations.

CWLS wold like to conduct a member survey to mesure our current demographics in order to better provide activities and courses geared towards specific groups. As a society we struggle to retain students as they transition to young professionals and would like to find ways to keep our young professional members active through courses and mentorship programs with our more experienced members. As always, we will continue to host monthly technical luncheons at the Palliser, and provide a high quality technical program at annual GeoConventions. However, we want to build upon these great perks of membership by adding new ones. Tiffiny Yaxley 2014-2015 Canadian Well Logging Society Membership Chair The accompanying Profit & Loss Statement and Balance Sheet reflects the financial position of the Canadian Well Logging Society (CWLS) for the year ended December 31, 2014. Dustin Menger (Past-President), James Ablett (President), and William Parrales (Vice-President), all members of the CWLS in good standing, in accordance with the CWLS by-laws, have reviewed the financial reports. The CWLS operated at a deficit of - **\$5,191.08** for the 2014 year. Expenses in 2014 were higher than expected, but the society received the expected revenues from membership dues (both personal and corporate), technical luncheons, joint conference (GeoConvention), short courses and sponsorships.

#### Membership

Total membership income decreased from \$29,711 for 2013 to \$20,252 for 2014. Dues will remain unchanged for members and new members for the 2014 renewals. The CWLS still offers the lowest dues of any petroleum society in Calgary.

#### **Technical Luncheons**

Our luncheons are subsidized by the society to maintain affordability for all members and non-members alike. The cost to CWLS on a per plate basis is approximately \$55. Members pay \$40 for reserved tickets and \$45 for tickets at the door. Non-members pay \$45. Corporate tables are purchased for \$400 per table which seats 8 people. The CWLS reserves a table every luncheon for student attendance at no charge to them. Audio video and visual service costs have double in comparison to 2013, resulting in higher costs for 2014. Luncheons consistently draw 100 plus people in the first two quarters and has decreased to 50-60 people for the rest of the year.

#### Fall Social

The Fall Social provides an opportunity to network with colleagues, students, and renew acquaintances. The cost for the 2014 event was \$1,555, which is consistent with the cost in 2013 for \$1,513. The event was held at Local 522 and approximately 50 people were in attendance.

#### **Annual General Meeting**

The AGM is the greatest fixed annual expense for the society. Part of the cost is offset with funding from sponsorship and ticket sales, but this is quite small. The society heavily subsidizes the AGM to maintain affordable ticket prices for all members. A major expense is the speaker's fee that has to be covered from general revenue. The 2014 Annual General Meeting operated at a cost of \$31,744. This is \$11,390 more than 2013, mostly due to an increase in guest speaker fees, room rental, and meal service. The 2014 event ran at a \$28,987 deficit.

#### **Publications**

The society published the InSite magazine in Spring 2014 online and brought in \$4,895 in advertising revenue.

#### Joint Annual Conference and Short Courses

This was the seventh year that the CWLS has been part of the Joint Annual Conference, GeoConvention, along with the CSPG and CSEG. Income from the conference, and the associated short courses, remained relatively unchanged, from \$135,423 in 2013 to \$138,328 in 2014.

#### Summary

Even though 2014 saw a year of higher expenses, the society received the expected income and maintains a very strong financial position. Our Scotiabank chequing/savings account has \$120,839 and has 3 newly opened GIC's valued at \$95,000 total. Our Scotia McLeod account has \$224,704 earning high interest. This year, the CWLS donated \$7,000 in sponsorship money to different student groups in efforts to give back to the student community, and to broaden the CWLS exposure.



I have enjoyed serving on the executive and I look forward to serving you again as treasurer again for 2015.
